Leave of Absence

Return to School

- 1. Apply to return to school at GLS during the application period.
- 2. Submit documents to obtain a 'Certificate of Admission' to the Office of International Student Services.
- 3. Requirements:
- Certificate of Admission Application Form
- Color Copy of Passport
- Copy of Health Insurance Registration Certificate
- 4. Apply for a new Student Visa (D-2) by yourself



Purpose: To encourage graduates to cultivate upright research ethics and offer fundamental education on how to write a thesis correctly.
 Who should be educated: Graduate freshmen or transfer students admitted as of 2017 who need to write a thesis.(Compulsory education; otherwise, cannot graduate)

Research Ethics Education

Research Ethics Board and research misconduct

① Research Ethics Committee

- Deal with rules about research ethics and operation of organization
- Deliberate and decide research misconduct

② Research misconduct

- Making non-existent data and research results untruthfully.
- By **manipulating research materials**, equipment and process artificially or changing or eliminating data randomly, distorting research contents or results.
- <u>Plagiarizing</u> from other creative people's research contents or results without justifying authorization or quotation(including overlapping publications).
- Unfair act of declaring a thesis's author : Not authorizing qualification to a thesis's author who has contributed his/her scientific/technical contribution to research contents or results without any valid reasons. Or authorizing qualification to a thesis's author who hasn't contributed his/her scientific/technical contribution to research contents or results as gratitude or respectful treatment.
- Distributing investigation about one's own or other people's misconducts on purpose.
- Getting out of the range recognized normally in the academic world.

• After a researcher publishes his/her work similar to or the same as his/her previous research result without any indicating sources , gaining unfair advantages such as receiving research funds or being recognized as additional research achievements.

• Judged Misconducts from research ethics board as it thinks the misconducts need investigation or prevention.

Institutional Life Ethics Education

1 Institutional Review Board : An organization established in SKKU according to TRules of life ethics and safety

2 e-IRB life ethics education in the school

- Electronic system e-IRB (http://www.eirbskku.co.kr) managing SKKU IRB online
- Free online class and issuance of educational qualification after joining the website(when you apply for IRB deliberation, attach the educational qualification)

③ Target for IRB Review

- Research conducted by intervening materially in humans
- Research conducted by interaction such as communication or personal contact
- Research using private information
- Research which investigates and analyzes composition of human body like tissue, cell, body fluid from human body or serum, plasma, chromosome, DNA, protein separated from these.

(4) Required documents and submission method when you apply for review:

Refer to e-IRB (www.eirbskku.co.kr) and upload required documents

- The period of application for review: on Thursday of the 3rd week every month(the end of application for review
 2 weeks before the regular date.
- **(6)** Announcement of review's result: Email research leader in 10 days after determining the review.

⑦ Sort of review's result

- Approval: Approve research subject
- Approval of correction: Approve it on the premise of correcting research subject partly(rapid approval)
- Supplementation: Rewrite research subject plan and review it the next regular review period.

Scholarship

✓ Scholarship for excellence international graduate students of Natural Science, Engineering, and Medicine (STEM Scholarship)

- Must be recommended by a professor at SKKU and meet with requirements.
 - Recommendation letter of Academic advisor, Confirmation letter for supported living cost (above 600,000 KRW per month)
- Up to 100% of the tuition fee can be provided as a scholarship depending on the result of the applicant's scholarship evaluation conducted by the department (college).
- [expected] Research-enrolled students could apply STEM scholarship from March 2018

* Students who were chosen for this scholarship when admission cannot change their scholarship to 'SKKU Scholarship (meritbased scholarship for International student)'. Also, STEM scholarship cannot be combined with 'SKKU Scholarship' either.

STEM Scholarship maintenance conditions

○ The STEM Scholarship student who satisfies one of the conditions below will be able to maintain the scholarship qualification.

[Merit based scholarship after enrollment]

* Based on previous semester's GPA: 4.2 or above: 100% / 3.8 or above: 70% tuition waiver

[Research performance]

- * SCI research paper (during the period of attendance in SKKU):
- lead author: 100% tuition waiver (granted from next semester after publishing paper until completion of attendance semester)
- co-author (within 3 co-authors) : 70% tuition waiver (only during next semester after publishing paper)

[Recommendation of academic advisor]

- * Based on previous semester's GPA: 3.8 or above 100% tuition waiver
- GPA 3.8 or less: granted based on registered students' graded level that was determined by each College's scholarship committee
